### ADVOCATE COMMISSIONS

To be eligible to receive commissions, Advocates must be considered active and qualified, as well as abide by the Crunchi Advocate Policies and Procedures, Terms and Conditions, and Advocate Credo. To be considered active, Advocates must abide by our Active Advocate Policy, which requires Advocates to purchase or sell at least \$400 in Personal Volume within a six-month consecutive period, and be current with the annual renewal fee of \$40.

To be qualified to receive commissions and be considered active for the month, Advocates must have \$150 or more in Personal Volume for that month. Personal Volume is a combination of client purchases and personal purchases. Qualified Advocates can earn up to 40% commission on their Personal Volume, and up to 10% commissions on their Team Volume.
